U.S. Export Control Compliance

The buyer understands the purchase of products from an IDEX company is subject, as applicable, under the Provisions of the U.S. Export Administration (EAR), the International Traffic in Arms Regulations (ITAR), and the U.S. Office of Foreign Assets Controls (OFAC).

The buyer understands the sale or distribution of products from an IDEX company may constitute an export, re-export and as such, must be done in accordance with the requirements of the applicable U.S. Export Control laws and regulations. The buyer confirms the goods will not be used for any purpose connected with chemical, biological or nuclear weapons or missiles capable of delivering such weapons. Therefore, the Buyer must consult the appropriate U.S. Government resources to ensure that the sale and distribution of products from an IDEX company is done in accordance with the applicable regulations. The parts covered in section 1 are controlled by the U.S. Government and authorized for export only to the country of ultimate destination for use by the ultimate consignee or end-user(s) herein identified. They may not be resold, transferred, or otherwise disposed of, to any other country or to any person other than the authorized ultimate consignee or end-user(s), either in their original form or after being incorporated into other items, without first obtaining approval from the U.S. government or as otherwise authorized by U.S. law and regulations.
